1. Definitions.

"You" (or "Your") shall mean the copyright owner or legal entity authorized by the copyright owner to make this Agreement with TUW. For legal entities, "You" comprises the entity making a Contribution and all other entities that control, are controlled by, or are under common control with that entity (according to § 15 GmbHG / §115 AktG) are considered to be a single Contributor.

"Contribution" shall mean the code, documentation or any original work of authorship, including any modifications or additions to the Netgen / NG Solve Software, that is submitted by You to TUW for inclusion in, or documentation of, the Netgen / NG Solve Software. For the purposes of this definition, "submitted" means any form of electronic, verbal, or written communication sent to TUW or its representatives, including but not limited to communication on electronic mailing lists, source code control systems, and issue tracking systems that are managed by, or on behalf of, TUW for the purpose of discussing and improving the Netgen / NG Solve Software, but excluding communication that is conspicuously marked or otherwise designated in writing by You as "Not a Contribution."

- 2. Grant of Copyright License ("Werknutzungsbewilligung"). You hereby grant to TUW and recipients of the Netgen/NG Solve Software a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable and sublicensable (for example, but not limited to, sublicenses by means of an Open Source License) license to edit or otherwise change Your Contributions and to use Your Contributions and edited or otherwise changed versions of Your contributions in any way possible now or in the future, for commercial and non-commercial purposes. This license includes (but is not limited to) the right the to reproduce, distribute and make available to the public (by wire or wireless means) Your Contributions and edited or otherwise changed versions of Your contributions..
- 3. Grant of Patent License. In case You are owner or exclusive licencee of a patent needed to make use of the rights granted by You under Section 2, You hereby grant a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable and sublicensable licence in said patent(s) to TUW and all recipients of the Netgen / NG Solve Software to the extent necessary to make use of the rights granted by You under Section 2.
